

ORDINANCE NO. 07-2025

AN ORDINANCE AMENDING AND SUPPLEMENTING THE TABLE OF ORGANIZATION AND RANGES OF COMPENSATION FOR EMPLOYEES OF THE TOWNSHIP OF EAST HANOVER

BE IT ORDAINED, by the Township Council of the Township of East Hanover in the County of Morris, New Jersey, as follows:

SECTION 5. There is hereby amending the established table of organization for part-time salaried positions with the Township of East Hanover amending titles and the range of compensation therefore for the period January 1st, 2025 through December 31st, 2025. Part-time salaried positions with the Township of East Hanover are appointed by the Township Mayor, in his or her sole discretion, and are not eligible for benefits including sick, vacation, health, dental, life insurance, and disability with exception of the Mayor, Council Members and Fire Director/OEM Coordinator shall receive life insurance at 3x times salary:



There is hereby supplementing the established table of organization for full-time Fire Fighter/EMT positions of the Township of East Hanover, setting forth titles established and compensation that shall be on an annual basis within the range, and shall be paid semi-monthly, therefore for the period January 1st, 2025 through December 31st, 2025.


