**ORDINANCE NO. 18-2024**

**AN ORDINANCE OF THE TOWNSHIP OF EAST HANOVER, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING THE TOWNSHIP CODE CHAPTER 59 “AMUSEMENT DEVICES” SECTION §59-2 “DESIGNATION OF AMUSEMENT PARK BOUNDARIES” TO INCLUDE ADDITIONAL RECOGNIZED AMUSEMENT PARKS**

**WHEREAS**, the Township Clerk has received a new amusement game application on behalf of Chuck E. Cheese located at Lot 9 in Block 99 on the Tax Maps of the Township of East Hanover and more commonly known as 145 Route 10, East Hanover New Jersey; and

**WHEREAS**, Township of East Hanover Township Planner has reviewed the Township of East Hanover Code and determined that the Code should be revised to include Chuck E. Cheese as a “Recognized Amusement Park” within the Township; and

**WHEREAS**, the Mayor and Council for the Township of East Hanover reviewed the recommendation of the Township Planner and desire to amend and supplement the Township Code Chapter 59 “Amusement Devices”, §59-2 “Designation of Amusement Park Boundaries.”

**NOW, THEREFORE, BE IT ORDAINED**, by the Mayor and Township Council that:

**SECTION 1.** The Township Code, Chapter 59 “Amusement Devices”, §59-2 “Designation of Amusement Park Boundaries shall be amended and supplemented to read as follows:

**§59-2 Designation of amusement park boundaries.**

It is hereby determined, declared and found that the Township of East Hanover contains a recognized amusement parks as defined in N.J.S.A. 5:3-31 and this chapter, said locations being designated as Lot 76 in Block 96 on the Tax Maps of the Township of East Hanover, and more commonly known as the "Funplex"; and Lot 9 in Block 99 on the Tax Maps of the Township of East Hanover, and more commonly known as the "Chuck E. Cheese."

**SECTION 2.** All ordinances or parts of ordinances inconsistent herewith are hereby repealed as to such inconsistencies.

**SECTION 3.** If any article, section, subsection, paragraph, phrase, or sentence is for any reason held to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase or sentence shall be deemed separable.

**SECTION 4.** This Ordinance shall take effect upon final publication as provided by law.
